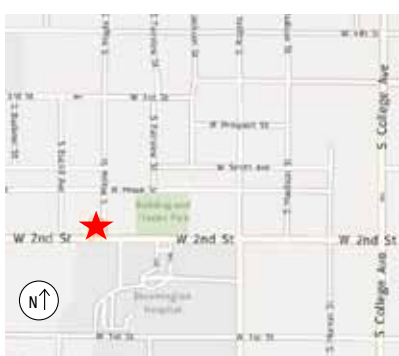

VOLUNTEERS IN MEDICINE: BRIDGING THE GAP

Margaret Mead once said, “Never doubt that a small group of committed citizens can change the world; indeed, it is the only thing that ever has.” Volunteers in Medicine is a testament to the power of our community to come together on behalf of the most vulnerable among us. The VIM “culture of caring” is the bridge across the gap between those with access to healthcare and those without it. It is an unfortunate truth that tens of millions of Americans live without any reasonable access to even the most basic medicine, and this scarcity is evident in our communities as well. Between Monroe and Owen Counties, an estimated 21,000 individuals meet the standards for being considered “medically underserved.” This definition includes being without insurance coverage and living at or below 200% of the Federal Poverty Guidelines.

Since opening its doors on April 23, 2007, the Volunteers in Medicine clinic has provided readily accessible, primary and preventive medicine without ever sacrificing quality of care. Medications are prescribed and filled on-site at no cost to the patient. Both acute and chronic conditions are managed, as well as life issues related to men-

tal/behavioral health and social work. Health education is a valuable tool to empower individuals to take control of their lives and well-being.

Moving forward, the Volunteers in Medicine clinic will continue to partner with every available practitioner, organization, and resource to accomplish continuously evolving, ambitious goals to provide high quality healthcare to people otherwise unable to access these critical services.

Every day dedicated employees and volunteers work to close the gap of scarcity and despair by bringing together our community with com-

passion and dignity to promote healing, enhance health, and create hope.

As we celebrate VIM’s fifth anniversary, we look back with gratitude for the generosity and vision held by so many individuals in Monroe and Owen counties not only for opening the clinic, but for sustaining it for five strong years. We are grateful to those who have supported our clinic with their contributions of time, funding, and resources enabling us to provide healthcare to those who have nowhere else to go. VIM is truly community-owned, community-operated, and community-financed. Thank you community!

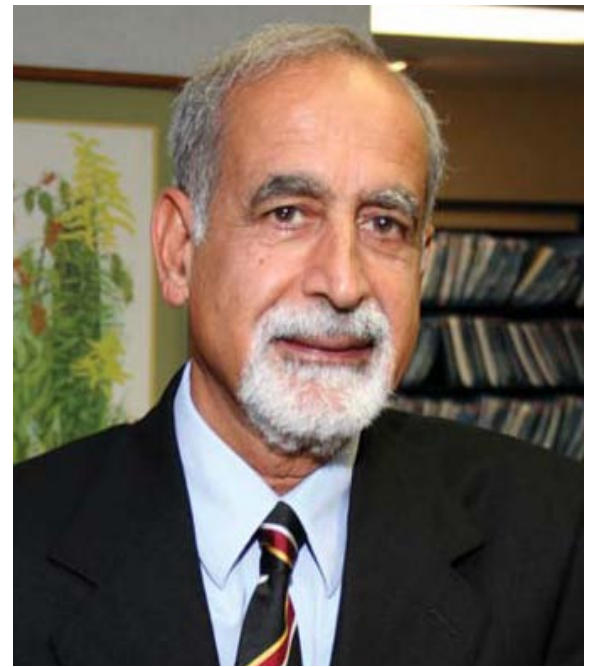

This publication highlights the growth and evolution of the VIM clinic over the past five years. There are a number of statistics showcasing the clinic’s progress from the opening five years ago to the present. We are pleased and humbled by the demonstrated demand for VIM services and the community support that has allowed us to meet these demands.

WHAT A DIFFERENCE A VISION MAKES

The vision of a free medical clinic staffed primarily by retired providers and lay volunteers came to life with the opening of the first Volunteers in Medicine clinic in 1992 in Hilton Head, South Carolina. Since that time, 89 VIM clinics have opened across the country. The concept was brought to Bloomington as an idea in 2005. With the passionate, visionary and relentless leadership of Dr. Rajih Haddawi, and through the work of a dedicated group of healthcare providers, (what was then) Bloomington Hospital, Bill and Gayle Cook, city and county government, community leaders, and the community at large, Volunteers in Medicine of Monroe County has grown into a successful organization that, today, barely keeps pace with demand. Clearly, Volunteers in Medicine is changing lives of so many individuals in Monroe and Owen Counties. Providing such a vital service to our patients is truly a privilege.

VIM NEWS

THE IMPACT OF THE SUPREME COURT DECISION ON VOLUNTEERS IN MEDICINE

The Supreme Court's affirmation of the constitutionality of the Affordable Care Act (ACA) allows the country to proceed with plans to implement the many provisions of this historic health care legislation. Since March 2010, when the legislation was passed, some provisions have already been implemented, resulting in previously uninsured Americans obtaining health coverage. However, major provisions of the law will not be implemented until 2014.

Volunteers in Medicine (VIM) Clinic of Monroe County will continue to be a critically important safety-net provider of healthcare services, both before and after the 2014 implementation date. Since the law was passed, as health care costs have continued to escalate at an alarming rate, more Americans have lost their health insurance and joined the ranks of the uninsured. Experts agree that even when millions of people are able to purchase affordable insurance as a result of the provisions in the ACA, there will still be millions of people who do not qualify for, or are excluded from applying for subsidized insurance. Those people in this situation in Monroe and Owen counties will continue to rely on the community-owned, community-financed, community-operated Volunteers in Medicine safety net for their health care.

States have significant power to shape Medicaid programs, and between now and 2014, preparation for implementation of the ACA among states will have enormous variability, and depend on a state's commitment to fund Medicaid subsidies for lower income residents to purchase health insurance through "exchanges". The insurance products offered through exchanges will vary greatly in cost and coverage. It remains to be seen how Indiana will respond to the Supreme Court's decision.

VIM remains a vital component of the physical, mental and economic health of our two-county community, and that will not end in the foreseeable future, even with the implementation of the Affordable Health Care Act. The community's ongoing investment in VIM will continue to assure access to quality, low cost medical care for those who remain uninsured after the implementation of this legislation.

VIM's mission is to offer quality health care in a caring and dignified environment to the uninsured of Monroe and Owen counties, and for as long as the pronounced need in our community remains, we shall endeavor to meet it.

NEW EXECUTIVE DIRECTOR NAMED IN 2012 - NANCY RICHMAN

In early 2012 the VIM Board of Directors named Nancy E. Richman, Ph.D., M.P.A., to the position of Executive Director following the resignation of Elizabeth Thompson. Richman joins Volunteers in Medicine from Indiana University Health Bloomington Hospital, where she served as the Senior Consultant in the Organization Effectiveness Department. Richman received her Ph.D. in Clinical Psychology at Boston University and



went on to get a Master's in Public Affairs degree at Indiana University, Bloomington, with a concentration in non-profit management. Richman has been active in the community having served on the board of directors at Middle Way House, and has lived in Bloomington for the past six years.

As executive director, Richman manages the operations of the clinic with a small staff of paid employees and hundreds of medical and lay volunteers as they provide care for thousands of patients. "Over the past six months, I have witnessed countless examples of employees and volunteers going above and beyond to provide a culture of caring and excellent medical services for our patients. It is a privilege for me to take the helm of this amazing organization and build on the solid foundation already set in place."

Richman replaced Elizabeth Thompson who had served as director of the VIM clinic since 2007.

WOMEN OWN THEIR WORDS

PATIENTS TELL THEIR STORIES: LETTERS TO VIM FROM GRATEFUL PATIENTS

MARK ACES

Several years ago a physician acquaintance, Dr. Corinna Repetto, introduced many colleagues of mine and myself to a new concept to provide healthcare to lower income, uninsured persons in the Bloomington community. Many of us gladly donated to this cause. I could not have imagined at that time that I would one day be a recipient of care from what became the current Volunteers in Medicine organization.



Life is a funny old dog; you never know where she'll curl up and lie down. Fast forward about six years, and I found myself unemployed and largely unemployable, savings depleted, dependent upon Social Security and insulin, and without health insurance. Worse, my spouse also suffered from diabetes and the multiple, harsh consequences of a traumatic brain injury. Our prescription bills alone totaled over \$1700 per month.

We turned to VIM. Upon being certified, we promptly received top quality care from some of the finest internists and specialists in Bloomington. Our prescriptions were covered. In short, our lives were saved from death by complications from diabetes and from the descent into emotional and psychological trauma that can result from brain injury.

While our nation debates how to provide needed healthcare to unserved millions, the physicians, nurse practitioners, nurses, social workers, pharmacists, techs, staff and volunteers at VIM are taking action. We don't know what the future of healthcare in America will be. We do know the deplorable state it is in now. Instead of debating, the people of VIM are acting. Their actions are making the difference between life and death, quite literal death, for those in our community who are uninsured and unable to afford healthcare services. They deserve the support and respect of all.

KATHY BELL

It happened gradually. Reading was the first thing to go. I thought all I needed was new eye glasses, but Dr. Smith said glasses weren't going to help. I had really bad cataracts and was going to need surgery. Me and my husband were out of jobs. I didn't know what to do or how to get help. Dr. Smith told me to go to VIM. I met with Jo and she worked really hard to find a way for me to have the surgery. Dr. Cohen agreed to do it. By April I was legally blind; I could see outlines, but I couldn't drive, read, clean, shop or anything. My husband had to do it all.



Dr. Cohen and the Surgery Center staff were wonderful. You'd think you'd get treated differently because you don't have money or health insurance. But that didn't happen. They were wonderful to me. Getting my eyesight back changed my life.

I have other health issues as well. I go to VIM for blood work every 6 weeks and have to take 11 scripts a month. My family was doing what they could to help me buy them, but now I get them at VIM. People don't realize what VIM does for people. Without VIM, my family, Dr. Smith and Dr. Cohen, I just don't know where I'd be today.

Dear VIM,

CHILDREN

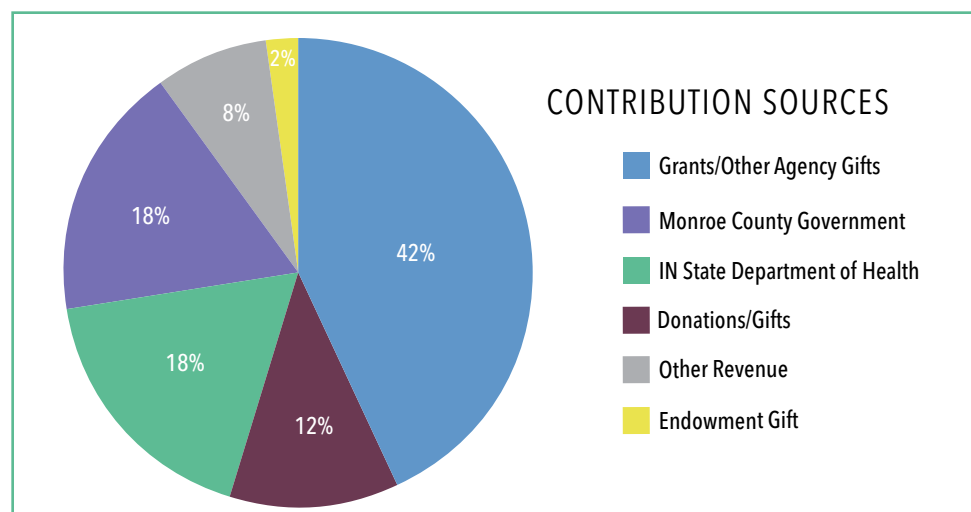

THREE PILLARS OF SUCCESS: THE PARTNERS THAT MAKE IT POSSIBLE



Beyond the hundreds of hours that local lay and medical volunteers devote to serving VIM patients, we could not have sustained our continued growth and evolution without our phenomenal financial partners. In particular:

INDIANA UNIVERSITY HEALTH BLOOMINGTON HOSPITAL

The Volunteers in Medicine clinic was built on the foundation established by Bloomington Hospital's Community Health Access Program (CHAP). IU Health Bloomington Hospital has generously continued its commitment to improving healthcare delivery in the local community by providing the clinic with three full-time employee positions, labs and other diagnostic testing, radiology, procedures, emergency, and inpatient services. IU Health providers are generous in their willingness to see VIM patients in their specialty offices. In addition, VIM and IU Health Bloomington's "Individual Solutions" office have partnered to develop a collaborative eligibility process to screen patients for Medicaid, Healthy IN Plan, and VIM eligibility at the same time. We are committed to helping people access healthcare services in the best way possible for them. Finally, VIM wishes to thank the Bloomington Hospital Foundation for tremendous assistance as our fundraising agent.

COOK GROUP

The support from the Cook Group has been invaluable. From the initial major contribution during the Founder's Campaign that allowed VIM to move from vision to reality, to the purchase of the Second Street building with continued building maintenance, housekeeping, and grounds upkeep, the Cook Group has clearly been one of the pillars of VIM's success. Bill Cook once said, "If we take, we must return. That is a sacred value." The Cook Group embodies this core value and Volunteers in Medicine is deeply grateful.

THE COMMUNITY: CITY, COUNTY, STATE & GRANT FUNDING

Also instrumental in the initial startup of the clinic was the City of Bloomington, Monroe County, United Way and many individuals, organizations and corporations. Significant support continues to be received annually by the IN State Department of Health and both Monroe and Owen County governments. Over the past five years grant support from the Susan G. Komen Foundation, Jack Hopkins (City of Bloomington), Baxter International Foundation, the Community Foundation of Monroe County, and the Monroe County Health Department (among others), have allowed VIM to pursue specific projects that continuously improve the care and services for our patients - for example, replacing critical pieces of equipment, funding mammograms for low-income women, replacing very old computers, purchasing glucometers and diabetic test strips to give to diabetic patients, dental supplies, providing pre-natal care for women not otherwise eligible for pregnancy Medicaid, and so forth. VIM was recertified as a United Way agency in 2010. We appreciate the generous support of these granting organizations.

THE COMMUNITY: PRIVATE GIFTS, DONATIONS AND IN-KIND SUPPORT

The demands for funding are never-ending - from expensive computer toner cartridges, office supplies, replacing aging equipment, flu vaccine, diabetic test strips, upgrading technology - the list goes on and on. Fortunately, VIM enjoys the financial support of a long list of individual donors. This includes significant in-kind support from vendors such as Smithville Telephone Co., ProBleu and Shredding Unlimited. Our heartfelt thanks and gratitude to our many donors for their one-time, annual, or in-kind financial support.

FIVE YEARS

GROWTH TO MEET DEMAND

ELIGIBILITY

VIM has made great strides in reaching the uninsured in Monroe and Owen counties, but the need continues to grow. As Table 1 shows, close to 9000 applications have been approved since we opened our doors, including both new certifications and 6-month recertifications. Over 5000 unique individuals have enrolled over the past five years. To keep pace with the steadily increasing applications, the VIM Eligibility Coordinator and volunteer representatives held over 6500 visits during 2011.

MEDICAL / DENTAL / BEHAVIORAL HEALTH

Over the past five years the demand for medical services has skyrocketed. VIM's main focus is to provide primary care for acute and chronic conditions at the clinic. Close to 10,000 medical visits were held during 2011. This can be equated to a monetary value of \$933,750.

For illnesses or conditions we are not equipped to serve on-site, we refer our patients to local specialists' offices. For example, all vision services are addressed off-site through a partnership with the IU School of Optometry and patients are seen at both the Community Eye Care Center and the Atwater sites. Through this partnership, patients receive eye exams and glasses at substantially reduced rates. We are grateful to our specialists, listed on page 6 who accept our patients.

In 2010, grant funding allowed us to purchase equipment to fully equip two dental rooms. This has allowed us to expand our dental services to include x-ray, extractions, fillings and tooth repair. One of the primary goals of 2012-2013 is to recruit additional dentists and hygienists in order to expand availability of appointments. Similarly, we are in the process of exploring avenues to recruit additional counselors and therapists to expand our behavioral health services during the next year as well.

PHARMACY

During 2011 VIM had over 11,000 patient visits to our medication room. This on-site "pharmacy" does not stock narcotics and is not a retail pharmacy, but exists solely to serve VIM patients who are unable to afford medications. During 2011, VIM provided 28,207 prescriptions at no cost; however often patients make voluntary donations. The retail value of these prescriptions was just under \$4.4 million.

WALK-IN

Walk-in patients are accepted depending on the availability of the healthcare providers and the urgency of the issue. A nurse practitioner staffs the walk-in clinic four days per week, including one evening. All patients who walk in without an appointment are evaluated by one of the staff nurses for an initial determination of the urgency of the issue. Thus, patients who walk in are either seen by a nurse practitioner that same day or with less urgent issues are offered an appointment within the next day or two. By offering walk-in services we can address acute issues that do not warrant a visit to the local emergency room. During 2011 close to 3000 walk-in patients were seen at VIM.

Table 1: Five Year Comparison of Key Indicators

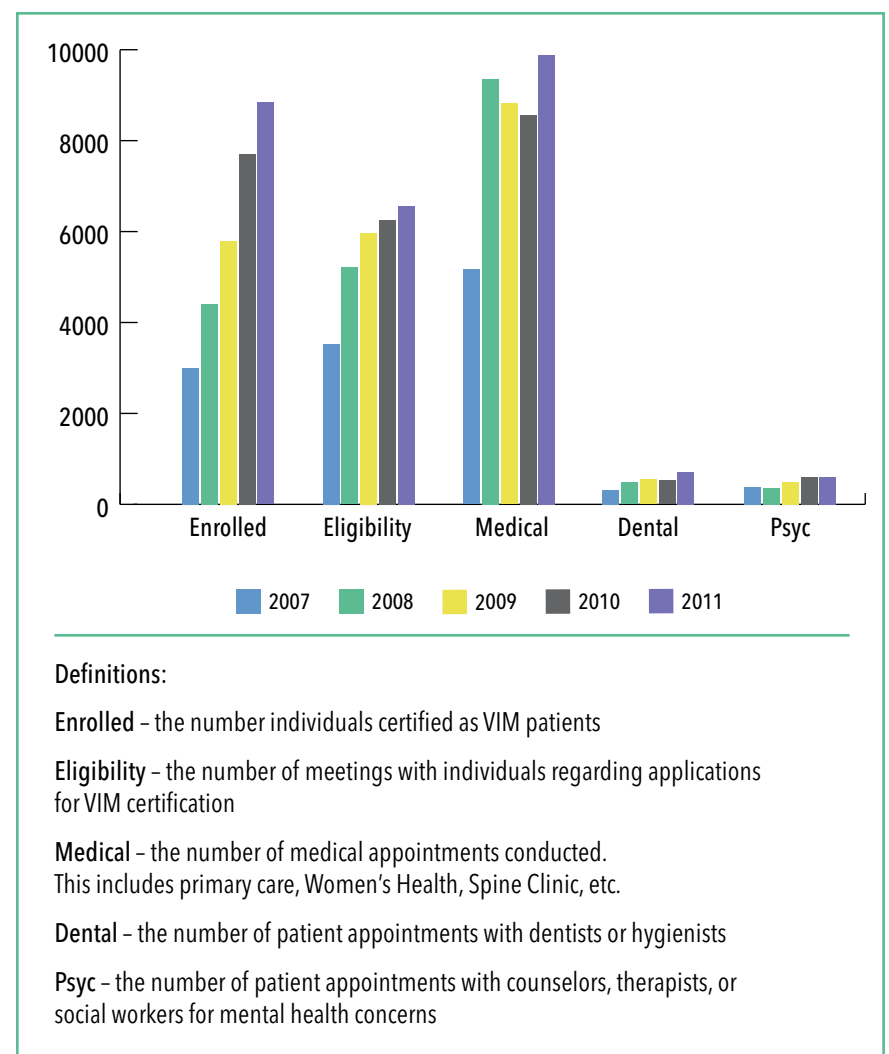


Table 2: Five Year Comparison of Number of Prescriptions Provided to VIM Patients

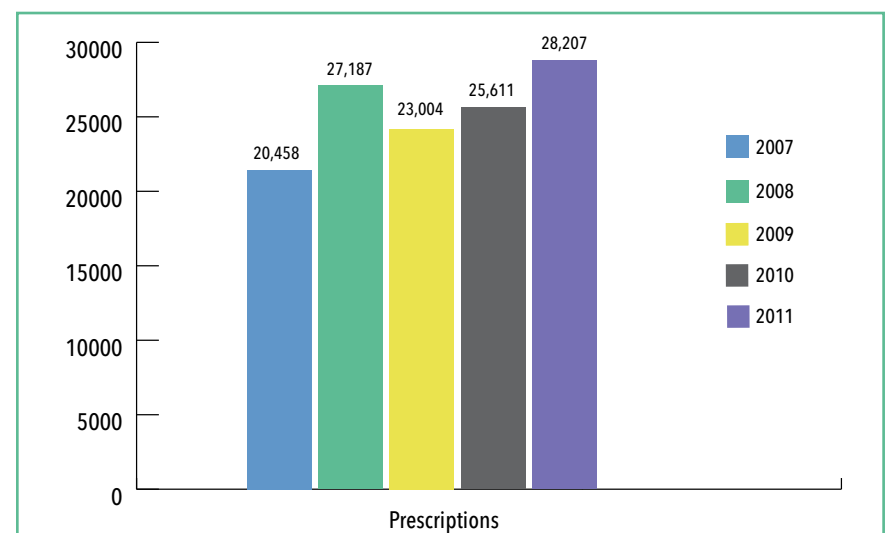
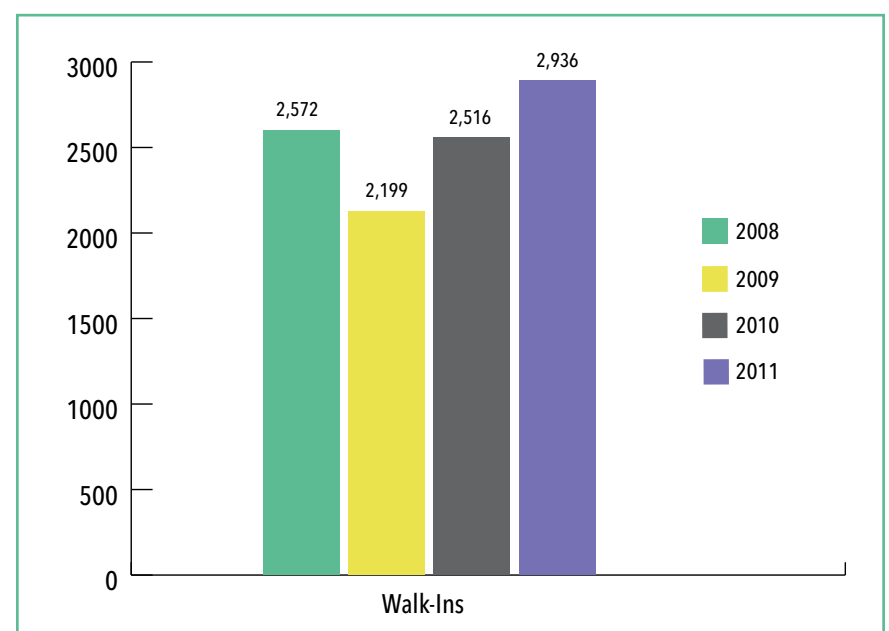


Table 3: Four Year Comparison of Number of Walk-in Patients

ELIGIBILITY FOR VIM SERVICES

THE VOLUNTEERS IN MEDICINE CLINIC SERVES PEOPLE WHO:

- Reside in Monroe or Owen counties.
- Do not have health insurance, Medicare or Veteran's Administration medical benefits.
- Meet asset eligibility requirements.
- Earn income equal to or below 200% of the federal poverty level per the chart below.

ELIGIBILITY REQUIREMENTS

To begin receiving services at the Volunteers in Medicine clinic, residents should come to the clinic to meet with an eligibility representative who will determine whether the resident meets the clinic's residence, income and eligibility requirements. Advance appointments are not needed for eligibility meetings.

The following documents will be needed at this appointment:

- Proof of Monroe or Owen County residence, such as a lease agreement, rent receipt or utility bill with current name and address
- A complete copy of the last federal income tax papers* including:
 1. Form 1040, pages 1 and 2, OR
 2. Form 1040EZ, AND
 3. All W-2s and/or 1099s, AND
 4. Any schedules, if filed.
- payroll check stubs or verification of the income for everyone in the household**
- your most recent statements that reflect the current balance and/or cash balance for checking and savings accounts, stocks, bonds, IRA/CD and life insurance
- additional income sources, such as: child support, food stamps, Social Security, TANF or unemployment.

* If you cannot locate a copy of your federal tax return, you may obtain one from the local IRS office located at 2017 S. Liberty Drive.

** If you are unemployed and not currently receiving any income, you must obtain a copy of form KWE3565 from WorkOne, the local employment office located at 450 S. Landmark Avenue
